Re: Invitation to participate in a competitive bid process for the custom development of a front-end and back end data capture, approval, and management system

The Mutual Aid Box Alarm System (MABAS) of Illinois is the managing recipient of grant funds from Urban Area Security Initiative. This is a competitive bid process utilizing performance based specifications.

MABAS is a state-wide agency that assists Fire Departments throughout the State of Illinois in times of emergency beyond their local capabilities.

MABAS is seeking a responsive and secure website enabling first responders to self-register for a credential to be generated from the existing MABAS credentialing system. The website must offer a robust bi-directional integration with the existing MABAS credentialing and accountability system.

Product Technical and Performance Based Specifications:

1. Fully integrates with existing credentialing and accountability system.
2. User authentication that leverages a unique phone number.
3. Returning website users can access their credential request page to view status.
4. Must be able to track self-registration account history.
5. Captures user information that corresponds with fields and organizations in the existing MABAS credentialing and accountability system.
6. Allows multiple security users to approve and deny credential requests.
7. Once the self-registered credential is approved, a new record must be generated in the existing MABAS credentialing system.
